Division 3 of their regulations. All licensed producers are required to comply with at

least level 7 security. To reach level 7, your facility needs to have significant security measures implemented. Detectors for unauthorized access attempts, interior layout logistics, electrical code compliance, alarm equipment monitored by an U.L.C. approved central monitoring station, functioning cameras 24/7 and others besides. You also need to make sure you're following all the rules relating to data privacy. 


